WE, THE UNDERSIGNED, of full age, being desirous of associating ourselves together for the purposes as hereinafter more particularly described, pursuant to and in conformity with the Membership Corporations Law of the State of New York

FIRST—That the particular objects for which said Corporation is formed are as follows, viz.:

To cultivate, promote, foster, sponsor and develop among its members the appreciation, understanding, taste and love of Puerto Rican Folklore and Culture; to create a musical, drama and arts center, own and maintain a place of reunion, by lease, purchase or otherwise, for the advancement of such purposes; to secure the interest of patrons of these pursuits; to encourage the composition of Folklore music and paintings for exhibitions and books, drama and music for production by its members so as to provide social activities, entertainment and amusement and the voluntary exploitation of their talents, all for no pecuniary gain; and to lawfully do any and all things necessary, suitable and proper for the accomplishment of these purposes.

To provide for recreational and social activities for its members and to foster friendship and mutual respect and to advance the cultural development of its members.

In order to carry on the foregoing objects this organization shall hold and participate in meetings, forums, panels, round table discussions, and all types of civic, artistic, cultural and sporting events.

SECOND—That the corporate name by which said Corporation hereby to be formed shall be known and distinguished is and shall be

THIRD.—That the territory in which the operations of said Corporation are to be principally conducted is in the City and State of New York.

FOURTH.—That the principal office of said Corporation shall be located in the City and State of New York
